**\*initial** ALL students enrolled MUST have a parent / family member who can volunteer and be involved throughout the school year through planning of field trips, parties, pep-rallies, concession stand, classroom, etc. There are NO EXCEPTIONS, family involvement is necessary. Our goal is to combine the best, attributes from, traditional home school, co-op, and private school. We want to give BOTH student and parent the tools to be successful.

**\*initial** ALL students are expected to participate in "Helping Hands Help Others," which are outside projects in which we HELP others / community. We believe that it is very important for a child to learn how to "give back," how to give rather than to receive.

**\*initial** YOU are responsible for providing your child's snacks & SACK lunch (NOTHING that needs to be cooked/warmed or refrigerated)

**\*Payment plans are available if needed:** (payments due the 1<sup>st</sup> of each month, **NOT** first class day)

**\*\*Discounts:** “Family Cap” Available to families with more than two students enrolled, \$600 monthly max per household

### Payment option *Initial one*

\_\_\_ Payment in full - Due at Round-up \$2,250.00

\_\_\_ 3 equal payments of \$750, First payment due at Round-up, 2 remaining consecutive payments due Dec. 1<sup>st</sup> and March 1<sup>st</sup>.

\_\_\_ 9 equal payments of \$250, First payment due at Round-up. 8 remaining consecutive payments due 1<sup>st</sup> of each month, Oct - May.

**Co-op Homeschool** (monthly rate)  \$50.00 Includes Thursdays

\$65.00 Includes Thursdays /report cards / Academic & or Sports Competition

(one time fee)

Yearly Achievement Testing, Stanford-Iowa-CogAT-other. Onetime fee \$50.00

Yearly Registration, *returning student* \$225.00 (per student) is non-refundable. Students are not enrolled until registration has been paid

Yearly Registration, *new student* \$250.00 (per student) is non-refundable. Students are not enrolled until registration has been paid

Curriculum: Foundations - \$150 / 1<sup>st</sup>-3<sup>rd</sup> – \$250.00 / 4<sup>th</sup>– 8<sup>th</sup> \$265 / 9<sup>th</sup>-12<sup>th</sup> \$275-\$350 dependent upon classes taken

Curriculum **must be paid by July 1<sup>st</sup> in order to get in each student order**

### Fee's (Initial)

Athletic Fee (see athletic handbook per sport)

Supply Fee - \$35 each student (covers additional supplies needed at school not included on school supply list.)

**Right to cancel:** You may cancel this contract within (3) business days of its execution without penalty.

**Relocation Privilege:** If student is permanently relocated a distance of 35 or more miles you may early terminate contract without penalty. Proof of relocation required,(electric bill that shows name and physical address.) If this contract is cancelled within 10 days of next scheduled payment, both next scheduled payment and any delinquent fees are due.

**Medical termination:** If student becomes permanently unable to attend school, you may early terminate this contract without penalty. Both current payment and any delinquent fees are due.

**Early Termination:** This contract may be cancelled at any time for any reason with **early termination fee of \$500.00.**

Delinquent accounts are ineligible for early termination until said fees are paid in full. If cancelled within 10 days of next scheduled payment, both the early termination fee and the scheduled payment are due.

**\*\*\*Zero tolerance for discipline problems!** If your student is expelled from school, YOU ARE STILL RESPONSIBLE FOR THE REMAINING YEAR OF TUITION.
